Platinum	a) In operation for more than 3 years or b) Annual sales turnover between RM 5 million and RM 50 million or c) The company consists of 75 to 200 full-time employees or d) Has recorded profits for the past two years or e) Has shown impressive performance in a particular industry.
Diamond	a) In operation for more than 5 years or b) Annual sales turnover of more than RM 50 million or c) The company consists of more than 200 full-time employees or d) Must record profits of more than RM 1 million in the current year or e) Has attained remarkable achievement in a particular industry.
